#### A-2 Public Comments-

A-5 The commission to discuss follow ups for properties found to be in violation.

#### A 5.1 606 Fannin Street- Dangerous Structure

Albert Cantu stated that this project is complete. House has been removed and cleaned up.

#### A 5.2 309 Wheaton Street-Dangerous Structure

Albert Cantu stated that this project is complete. House has been removed and cleaned up.

#### A 5.3 1600 Maiden Lane-Dangerous Structure

Albert Cantu stated that this property has a new owner. Permits have been obtained from the City and they are moving forward with repairs.

#### A 5.4 406 Burnet Street-Dangerous Structure

Owner Rosie Reza present. Ms. Reza stated progress is being made, cleaning and repairing property. Albert Cantu stated that slow progress is being made. Albert recommended that Ms. Reza be allowed time to continue repairs. Motion was made to allow the owner to return to January 22, 2018 meeting to report progress. Motion by Robert Hodge, second by Bobbie Williams. Motion carried.

#### A 5.5 1104 South Third Street-Dangerous Structure

Property owner Mr. Alvarez was present. Mr. Alvarez stated that he and his father (also present) are working on the house. He is waiting to save funds to complete it. He stated that he has raised and leveled the house. Albert Cantu stated that the house needs further securing. Mr. Alvarez said he will secure the property in one week. Motion was made to allow owner 2 weeks to secure the house and property and return to the January 22, 2018 meeting with a progress report. Motion carried by Robert Hodge, second by Jim Jackson. Motion carried.

#### A 5.6 514 Travis Street-Dangerous Structure

Albert Cantu stated that this property is 95% demolition complete.

#### A 5.7 708 Lettie Street-Dangerous Structure

Albert Cantu stated that someone has purchased this property and has pulled permits with the City to remodel. Remodeling is almost complete.

#### A 5.8 1015 Preston Street-Dangerous Structure

Albert Cantu stated that the owner had presented plans to the City for remodeling. The plans that were submitted were not satisfactory and were denied by the Building Official. The owners were told to bring in better plans for submittal. The yard was clean and the house was secure. Owner did not come to the meeting to give a progress report. Motion made to allow owner till January 22, 2018 meeting to give a progress report. Motion carried by Robert Hodge, second by Jim Jackson. Motion carried.

#### A 5.9 1012 Calhoun Street-Dangerous Structure

Albert Cantu stated that the property has been cleaned up. The dumpster is still on site. No action necessary.

## A 5.10 603 Fannin Street-Dangerous Structure

Albert Cantu stated that the house has been demolished and cleaned up. Some minor cleaning remains to be done. No action necessary.

#### A 5.11 206 Fleming Street-Dangerous Structure

Albert Cantu stated that a 30 day notice letter has been send. The owner had demolished part of the house but is not complete. Dumpsters are still on site. No action necessary.

#### A 5.12 907 South Sixth Street-Dangerous Structure

Albert Cantu stated that a 30 day notice letter was mailed out. The owner has been located. The owner has a contract to demolish the structure. No action necessary.

# A 5.13 912 Thompson Highway-Dangerous Structure

Owner Bill & Pam Zemanek are present. Mr. Zemanek stated that he has a plan to give the property a "facelift". Elements of his plan were distributed to the commission. Mr. Zemanek said he should complete these items in 30 days, and he plans to use the house for storage only. He also visually described his plan. Albert Cantu stated that the City inspected the house. Motion to allow owners until January 22, 2018 meeting to complete repairs. Motion by Jim Jackson, second by Robert Hodge. Motion carried.

# A 5.14 1621 George Avenue-Dangerous Structure

Albert Cantu stated that owner has completed the porch repairs. Owner will come to the January 22, 2018 meeting with a progress report. No action necessary.

The owner stated that they want to meet with the City building official for inspection, then turn water and electricity on. Albert Cantu recommended that the commission allow owners until next meeting, January 22, 2018 to report progress. Motion to allow owners until January 22, 2018 meeting to report progress. #### A 6.3 509 Fannin Street- Dangerous Structure

Property represented by owner Mrs. De Los Santos. The house has been listed as a Dangerous structure. Albert Cantu stated that the house needs to be demolished.
