Wayfinding Signs Assist Richmond Visitors

The City of Richmond now welcomes visitors to our city with 13 Wayfinding signs helping to orient them to the area and toward their destination. You may have seen some of these signs on Jackson Street, Williams Way, or Thompsons Highway. They reflect the Richmond brand and incorporate eleven different locations including Historic Downtown, Morton Cemetery, George Park, Freeman Town Park, Fort Bend Museum, Justice Center, Hospital (Oak Bend), Long Acres Ranch, County Courthouse and Wharton County Junior College.

The need for Wayfinding signs was recognized several years ago after the adoption of the City's Comprehensive Master Plan. Wayfinding is the practice of orienting people within their environment.....guiding them where to go in communities through signage. The need may be driven by tourism, history or economic development. Whatever the reason, wayfinding programs have become necessary in this very mobile society today. Richmond recognized the need to easily guide citizens to the Historic District and other points of interest as well as institutions like Oak Bend Medical Center. The planning and development of a branded wayfinding system included citizens of the City of Richmond as well as the Commission.

Richmond's City Commission approved a wayfinding signs contract with National Sign Plazas after a request for proposal was issued earlier this year.

MESSAGE FROM THE MAYOR



2018 was a year of recovery for many and also a year of new beginnings. We saw the beginning of increased use of our Wessendorff Park trail system since the trails were completed. The city's Trails Master Plan guided us toward completion Mayor Evalyn Moore of the water fountain at the eastern edge of Wessendorff Park (pictured

above). We are glad so many families have enjoyed this water feature.

We hope you have seen some of the Wayfinding signs in the market since that project completed in November 2018, and is the feature story for this newsletter. The need for wayfinding signs was identified in Richmond's Comprehensive Master Plan as an important tool for creating sense of place and directing visitors to our city.

We will continue to look to the future with partnerships for development opportunities appropriate for central Fort Bend County. House Bill 533 will be introduced this upcoming legislative session which would allow the City of Richmond to capture sales and hotel tax revenue to fund a hotel/ convention center. This legislation would allow Richmond to receive the same benefits afforded 37 other Texas cities, as well as some in the Houston area, through prior legislation. This has the potential for positive economic impact on Richmond, necessary since we sit in the center of increased population growth in this county.

As we move into 2019 our focus will continue toward improved services with Fire Station 2 completion at end of 2019. The area's population growth encourages us to continue to update our various master plans anticipating the increased demand on services, such as our utilities. Know that your city is in good position and prepared for this growth, while making sure we retain our unique historic charm which draws people to Richmond. Richmond continues to be a great place to live, work and play!







RICHMOND PARKWAY SOON TO BE REALITY



The City of Richmond has moved closer to achieving a key goal of its Comprehensive Master Plan. The Master Plan recognizes the importance of increasing awareness of our dynamic city in the region, and creating a signature gateway into Richmond is a priority to accomplishing this goal. As a result, the City Commission of Richmond has voted in favor of renaming the portion of Second Street, from US Hwy. 90-A to Austin Street, and Austin to Front Street, and Front Street, which becomes Williams Way south to the city limits, to Richmond Parkway in the future.

This name change is part of a coordinated effort between the City of Richmond and Fort Bend County. On November 27th, 2018, the Fort Bend County Commissioners Court approved renaming the County's portion of Williams Way extending south from Richmond's city limits to US 59, as Richmond Parkway. Upon completion, this renaming will consolidate segments of Front Street, Austin Street, Second Street and Williams Way between U.S. 90A and U.S. 59 to create a unified entrance corridor to the City of Richmond. Utilizing a single name for the entire roadway will strengthen awareness and bolster the City's image by providing important way-finding and community branding.

This name change will be an involved process as it includes communicating with residents and businesses along this roadway. The City of Richmond will lead all coordination efforts for 911 services, US Postal Services and utility and transportation related services. The City has also planned future mobility improvements for the corridor that will enhance the connectivity of the Judicial Center to Richmond's historic district and downtown area.

Richmond's Fire Station #2 Begun Construction

As with Richmond's Central Fire Station on Houston Street and Fire Station 3 on Mason Road, the City's streets teams have begun the clearing and leveling of the land, prior to construction of Fire Station 2, to adhere to allocated budget. The Commission has approved the plan for driveway locations which calls for entry from Ransom Road and exit when they leave onto Williams Way Boulevard. City Attorney, Gary Smith, explained the goal is to have a 'drivethrough' fire station to allow the property to work most efficiently. Efficiency is important since Chief Mike Youngblood believes Fire Station 2 will probably be the department's busiest due to the density of the population surrounding this location.

The projected cost of construction for Fire Station 2 is \$1.9 million and is targeted for completion late 2019.







City Streets Department Repairing Sidewalks



You may have seen city personnel repairing your sidewalk recently. This is due in part to the City's Public Works department completing a sidewalk assessment in August followed by an amendment to the City's driveway, sidewalk, culvert repair policy, which in some cases held residents responsible for sidewalk repair. The City is now responsible for any ongoing maintenance and repairs to sidewalks and curbs, as well as any driveways damaged by elevation changes from street repairs. There are 114,076 feet of sidewalk in the City of Richmond, some of which is cracked due to age or tree roots which have caused some sidewalks to rise in certain areas. Under the old regulations, repair to the sidewalks fell to the homeowner. This has changed for Richmond residents.

Under the new ordinance, changed by the amendment approved at the September commission meeting, sidewalk repairs are broken into three categories based on priority. Sidewalks with 'trip hazard' of two inches or more are first priority for repair, followed by sidewalks with trip hazard between one and two inches and third priority with trip hazard between a half-inch and one inch. The goal within this next year is to address and repair as many priority one trip hazards as possible beginning on the North side of the City and moving south.

The Street Department began replacing defective sidewalks in late August and have replaced 383.5 ft. of sidewalk by early December in addition to their other responsibilities. The City of Richmond has 36,192 total feet of sidewalks needing repair and residents should be seeing the benefit of this ordinance change soon.

CITY DRAINAGE UPDATES ARE PLANNED



Richmond's Public Works Department is in the final stages of completing a Drainage Master Plan that covers the entire City. The plan is basically broken into two pieces - the north and the south drainage basins with HWY 90 being the dividing line. Hydraulic analyses were completed focusing on the 10, 25, and 100 year storm events. The City is awaiting word on several prospective projects that have been submitted to FEMA for funding consideration.

RICHMOND FIRE STATION MASCOT A TRADITION

The tradition of the dalmatian as the firehouse dog began in early days when fire vehicles were horse-drawn carriages. It was discovered the dalmatian had three useful qualities- speed, endurance and an affinity for horses. For these reasons the dogs were easily trained to run in front of the engines to help clear a path and guide the horses to the fire quickly. As well, they helped calm the horses at the fire. Today they serve purpose more as a mascot.

Ever the fire department to keep true to tradition, the Richmond Fire Department added their fourth female dalmatian this year, thanks to the sponsorship of Dr. Michael Moore of Foster Creek Veterinary Hospital in Richmond, Texas. Lady IV joined the team in the spring, and none too early, so she could be mentored by Lady III preparing her for her duties carrying on the tradition of the dalmatian firehouse dog.

The Department mourned the passing of Lady III just before Christmas as she served 14 years for the department. As she was only the third dalmation mascot, since tradition began in 1981, it was a difficult time to say goodbye. Her longevity had her serving 4 years longer than Ladys I and II, and she was loved by many in the community.



DEVELOPMENT CORPORATION OF RICHMOND ACCOMPLISHMENTS

2018 was an active year for the DCR that ended with the organization being named the Economic Development Organization of the Year by the Central Fort Bend Chamber of Commerce. Several important achievements occurred including creating a new website, implementing a downtown area improvement program, completing a target industry study, installing wayfinding signage throughout Richmond, hosting a second chance job fair, and developing an updated marketing strategy.



Target Industry Study

A target industry study was completed June 2018 to help identify which industries are most suitable for Richmond's geographic area and build upon its area's strengths. A major benefit of the study is that it allowed the DCR to focus its business recruitment strategies specifically on the industries identified by the study. The study was conducted by Economic Modeling Specialist Inc. (EMSI) over a five month period that included multiple site visits to Richmond, community meetings, focus groups with key stakeholders, and the analysis of demographic and employment data.

Opportunity Zone Program

The Tax Cuts and Jobs Act of 2017 created a new community development program in rural and urban communities intended to increase private investment. The program provides a tax incentive for investors to reinvest their unrealized capital gains into Opportunity Zones. The selection process for which areas to include in the program was competitive with only a quarter of eligible tracts being selected by Governor Greg Abbott. The City of Richmond and DCR were successful in receiving 2 of the 5 opportunity zone area designations in Fort Bend County.

CITY RECEIVES SUPPORT FROM ACCESS HEALTH


The City of Richmond Parks and Recreation Board recognized Palak Jalan, Senior Director of Population Health for AccessHealth, at their January board meeting. With a grant from The Episcopal Health Foundation, AccessHealth was able to allocate \$20,000 to the City of Richmond with intent it be used for park enhancements recommended by the City's Parks and Recreation Board. AccessHealth has been serving the Richmond community for more than 40 years as a community health center. In 2017, they began working with community partners to address conditions within the community with purpose to prevent common health problems such as diabetes, hypertension and depression.

AccessHealth advocates for residents to be active and a city park system with trails provides the conditions to encourage residents to become more active. By contributing toward the City's parks and trails system,



AccessHealth felt this provided the most potential to impact the health of their patients and the Richmond community at large.

CITY'S UTILITY MASTER PLAN

We have all noticed the growth in the area and realize our idyllic little City is growing. While the city has no intention of yielding to pressure of growth for the sake of growth, it is inevitable. Your City Government and Staff are therefore staying 'out in front' of the growth with a City sponsored Utility Master Plan to enable us to accommodate quality growth, consistent with

our heritage and values. The good news is we are a very old city with charm, history and heritage that goes with that distinction, though the age of our city also carries the accompanying problems presented with an aging infrastructure of such a historical city.

In our Utility Master Plan we will be looking at the most efficient ways to upgrade our existing facilities, and develop new infrastructure to facilitate our planned quality growth. Further, we are mandated by the Fort Bend Subsidence District to achieve 60% surface water usage by 2025, which will require us to build more facilities to treat the surface water.

This will be a 5 year plan based on present projections, but as needs "on the ground" change, we will be continually monitoring implementation to make sure we are the best stewards of the taxpayer's money, while at the same time providing excellence in our service to our Community.


