It shall specify which trees are to be relocated, removed or replaced, tree protected zone limits and highlight all trees that are over nineteen inches (19") in diameter. The plan should include the proposed developed are overlay depicting the building footprint, flatwork (street, drives, parking lots, sidewalks, etc.) and all other proposed improvements. Landscape Plan: Any proposed landscaping which should include the size and number of proposed new trees with In accordance with City Ordinance 2005-22: No person shall cut, remove, encroach into the protected zone or relocate and tree larger than 19" in diameter or on any public or private property within the City unless a valid tree permit has been issued by the City Building Office. Condition of Removal: Payment of \$200 per removed tree up to a maximum of \$4,000 All approvals on this application will expire after 180 days of filing unless a permit is issued or a written request for extension is received. **FEES** All fees due to the City of Richmond shall be paid in full before issuance of the permit. All returned checks will be assessed a returned check fee as applicable and a stop work order will be issued and remain in effect until such time a valid complete payment is received. "Credit card payments are assessed a 3% convenience fee.
