

Property Tax Under Senate Bill 2

- Senate Bill 2
 - Property tax reform act passed during the 86th regular legislative session
 - Lowers voter approval rate from 8% to 3.5%
 - <30,000 population must calculate de minimis tax rate
 - De minimis tax rate is the rate that would generate \$500,000 in property tax
 - Automatic Election:
 - Exceed the de minimis tax rate
 - Voter Petition for Election:
 - Adopted rate is equal to or lower than the de minimis tax rate and greater than the voter approval tax rate



Property Tax Under Senate Bill 2

- Senate Bill 2 Key Concepts
 - Creates barriers to growth in revaluation above 3.5%
 - Forces the movement of the nominal tax rate
 - This is part of the transparency initiative of Senate Bill 2
 - Senate Bill 2 is designed to force Cities to move away from a stable tax rate that generates more revenue from revaluation to one in which the tax rate moves to generate growth
 - Be prepared for the possible need to adjust the tax rate in the upcoming years to capture 3.5% growth (it depends on several factors including revaluation, lawsuits, etc.)



Property Tax Key Terms

- No-new-revenue Tax Rate
 - Is the rate that will provide a taxing unit with the same amount of revenue on properties taxed in the preceding year
- Voter Approval Tax Rate
 - Is the rate that will provide a taxing unit with no more than a 3.5% increase on the same properties taxed in the preceding year
 - Adjusted for (not all inclusive):
 - Lawsuits/court ordered reductions
 - Sales tax for property tax reduction gain
 - Debt payments



Property Tax Composition – Net Taxable Value






Property Tax Composition

RESIDENTIAL VS. COMMERCIAL







Truth in Taxation - Adoption Process

- In addition to publishing notices in the Newspaper and on the City website, the following additional steps must be taken:
- Public Hearing on the Budget
- **II.** Budget Adoption
 - Budget must be approved before the Tax Rate
 - Simple majority
- **III.** Public Hearing on the Tax Rate
- IV. Approval of the Tax Rate
 - Super majority
 - > Adopted in two parts
 - Maintenance & Operations
 - Debt Service
- Record vote to ratify the tax rate increase in the budget
 - I. Separate Item on the agenda



Publication of Maximum Tax Rate

- Record Vote on Notice to Publish Tax Rate:
 - The Texas Tax Code Requires that vote of all members of the governing body appear on the Tax Rate Notice.
 - The Proposed Tax rate of \$0.687772 per \$100 value is less than the prior year, however, due increases in property values there is a slight tax increase which triggers the tax rate increase provision.
 - In accordance with Section 26.06 of the Texas Tax Code "NOTICE, HEARING, AND VOTE ON TAX INCREASE", I move that the maximum tax rate published be set at \$0.687772. The public hearing having already been set on September 8, 2020, at 4:30 PM, at 600 Morton Street.

ORDINANCE NO. 2020-19

AN ORDINANCE OF THE CITY OF RICHMOND, TEXAS, AMENDING RICHMOND CODE, CHAPTER 14 "HEALTH," ARTICLE III "PANDEMIC FACE COVERING," REQUIRING A PERSON INSIDE AN ENCLOSED, CLIMATE-CONTROLLED CITY BUILDING AND WITHIN SIX FEET OF ANOTHER PERSON TO WEAR A FACE COVERING; PROVIDING A REPEALER CLAUSE; PROVIDING FOR SEVERABILITY; PROVIDING A PENALTY CLAUSE; PROVIDING FOR PUBLICATION AND AN EFFECTIVE DATE; AND CONTAINING OTHER PROVISIONS RELATING TO THE SUBJECT

WHEREAS, on March 13, 2020, a Declaration of Local Disaster for Public Health Emergency was issued to allow the City of Richmond to take measures to reduce the possibility of exposure to COVID-19 and promote the health and safety of Richmond residents; and

WHEREAS, on March 13, 2020, a Declaration of State of Disaster was issued by Governor Abbott to take additional steps to prepare for, respond to, and mitigate the spread of COVID-19 to protect the health and welfare of Texans; and

WHEREAS, on March 16, 2020, President Donald Trump acknowledged the gravity of the COVID-19 pandemic, releasing strict new guidelines to limit people's interactions: and

WHEREAS, on March 16, 2020, the City Commission at a Regular Commission Meeting approved an extension of the Declaration of Local Disaster for Public Health Emergency; and

WHEREAS, due to the continued rapid spread of COVID-19, on April 2, 2020, additional measures were necessary to protect the ability of the public and private health care providers to handle the influx of patients, and safeguard public health and safety, except for certain essential activities and work to provide essential business and government services or perform essential business and public infrastructure; and

WHEREAS, to protect lives while continuing the essential functions of city government, city buildings were closed to public access; and

WHEREAS, as the pandemic continues and when the City reopens its facilities to the public, it is necessary to protect the health and well-being of the public and city employees to require a person within an enclosed, climate-controlled city building utilized for conducting or transacting business with the public to wear a face covering when within six feet of another person; and

WHEREAS, the City Commission of the City of Richmond now deems it in the public interest to require persons to wear cloth face masks covering the mouth and nose while inside of an enclosed, climate-controlled city building utilized for conducting or transacting business with the public and within six feet of another person; **Now Therefore**,

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF RICHMOND, TEXAS:

<u>Section 1.</u> The facts and recitations set forth in the preamble of this Ordinance are hereby found to be true and correct.

<u>Section 2.</u> Article III "Face Coverings," of Chapter 14 "Health," of the Code of Ordinances, City of Richmond, Texas is hereby created to read as follows:

"Chapter 14 – HEALTH

. . . .

ARTICLE III. – Face Coverings

Sec. 14-101. – Face covering required.

- (a) A person who is inside an enclosed, climate-controlled city building utilized for conducting or transacting business with the public shall wear a cloth face covering over the person's nose and mouth.
- (b) A person inside an enclosed climate-controlled city building is not required to wear a cloth face covering required by subparagraph (a) above if the person is not within six (6) feet of another person.

Sec. 14-102. – Affirmative Defense.

It is an affirmative defense to a charge of not wearing a cloth face covering inside an enclosed, climate-controlled city building utilized for conducting or transacting business with the public if:

- (a) The person has a medical condition or disability that prevents wearing a cloth face covering and such condition or disability is documented by a physician;
- (b) The person is under the age of ten (10) years; or

(c) The person is voting, working as a poll watcher, assisting a voter, or administering an election.

Sec. 14-103. - Penalty.

- (a) The first violation of Sec. 14-101(a), will result in the person will receive a verbal or written warning.
- (b) A person who commits a subsequent violation of Sec. 14-101(a) shall be deemed guilty of a misdemeanor and, upon conviction thereof, shall be fined in an amount not to exceed Two Hundred Fifty Dollars (\$250.00).
- (c) A person may not be detained, arrested, or confined in jail for refusing to adhere to this ordinance. A law enforcement officer may consider someone who refuses to wear a cloth face covering as required by Sec. 14-101(a) and refuses to leave the enclosed, climate-controlled city building utilized for conducting or transacting business with the public a trespasser."

<u>Section 3.</u> Repealer. All ordinances and resolutions, or parts of ordinances and resolutions, in conflict with this Ordinance are hereby repealed, and are no longer of any force and effect.

<u>Section 4.</u> Severability. In the event any section, paragraph, subdivision, clause, phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstance shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair, or invalidate this Ordinance as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Commission of the City of Richmond, Texas, declares that it would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, or whether there be one or more parts.

<u>Section 5.</u> Effective Date. This Ordinance shall become effective and be in full force and effect from and after its passage, approval, and publication.

ORDINANCE NO. 2020-20

AN ORDINANCE OF THE CITY OF RICHMOND, TEXAS, PROVIDING FOR A GENERAL ELECTION SCHEDULED TO BE HELD ON MAY 2, 2020 AND POSTPONED UNTIL NOVEMBER 3, 2020, FOR THE PURPOSE OF ELECTING A MAYOR FOR A TERM OF OFFICE FROM 2020 TO 2023; PROVIDING FOR A JOINT ELECTION SCHEDULED ON MAY 2, 2020 AND POSTPONED UNTIL NOVEMBER 3, 2020, WITH OTHER ENTITIES CONTRACTING WITH FORT BEND COUNTY FOR THIS JOINT ELECTION; PROVIDING FOR ELECTION PRECINCTS AND POLLING PLACES; PROVIDING FOR REPEAL; PROVIDING FOR SEVERABILITY; AND CONTAINING OTHER PROVISIONS RELATING TO THE SUBJECT

WHEREAS, the City Commission of the City of Richmond, Texas (the "City") has determined that a general election should be held in the City for the purpose of electing a Mayor at-large from the City; and

WHEREAS, the City Commission wishes to proceed with ordering such election and the City Commission has determined that holding such election on a uniform election date is in the public interest;

WHEREAS, the May 2, 2020 election was postponed until November 3, 2020 due to the coronavirus pandemic; NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF RICHMOND, TEXAS:

<u>Section 1.</u> That a general municipal election is hereby called and ordered for the 3rd day of November, 2020, at which election all qualified voters residing within the corporate limits of the City of Richmond may vote for the purpose of electing a Mayor at-large for a full three-year term. Said election shall be held in accordance with the Texas Election Code.

<u>Section 4.</u> That the polls of each of the polling places on election day shall be open from 7:00 a.m. to 7:00 p.m.

<u>Section 5.</u> That early voting by personal appearance shall be at the locations, dates, and times as set forth in Exhibit B, attached hereto and made a part hereof. Exhibit B may be automatically modified without the necessity of further action of the City Commission to include additional or different early voting locations, dates, and times designated by the Fort Bend County Elections Administrator to conform to the Joint Election Agreement and Contract.

<u>Section 6.</u> Early voting by personal appearance shall be by the EVS 6020 voting system by Election Systems & Software. Early voting by mail shall be by paper ballot processed through the EVS 6020 voting system by Election Systems & Software by an Early Voting Ballot Board.

<u>Section 7.</u> The Fort Bend County Elections Administrator shall receive applications for ballots to be voted by mail until the close of business on Friday, October 16, 2020. AMENDMENT TO JOINT ELECTION AGREEMENT AND CONTRACT FOR ELECTION SERVICES

THIS AMENDMENT made by and between Fort Bend County, a body corporate and politic under the laws of the State of Texas, acting herein by and through the Fort Bend County Elections Administrator pursuant to Texas Election Code Section 31.092, hereinafter referred to as the "County", and the City of Richmond hereinafter referred to as "Political Subdivision." Both may be referred to herein individually as a "Party" or collectively as "Parties".

RECITAL

Whereas, the Parties executed and accepted that certain Joint Election Agreement and Contract for Election Services on February 17, 2020, herein after the "Contract" for a joint election to be held on May 2, 2020, pursuant to Texas Election Code Section 271.002; and

Whereas, the Parties desire to amend the Contract to reflect a change in the date of the General Election due to delays caused by the COVID-19 Coronavirus pandemic.

NOW THEREFORE, in consideration of the mutual covenants, agreements, and benefits to the parties, IT IS AGREED as follows:

Generally, all references in the Contract to a General Election date of May 2, 2020 shall hereby be changed to November 3, 2020

III. Voting Locations

If polling places for the November 3, 2020 joint election are different from the polling place(s) used by Political Subdivision in its most recent election, Political Subdivision agrees to post a notice no later than November 3, 2020 at the entrance to any previous polling places in the jurisdiction stating that the polling location has changed and stating the polling place names and addresses in effect for the November 3, 2020 election.

XV. COST ESTIMATES AND DEPOSIT OF FUNDS

It is estimated that Political Subdivision's obligation under the terms of this agreement shall be \$6,734.00 The Political Subdivision agrees to pay to the County a deposit of \$4,040.00 which is approximately sixty (60) percent of the total estimated obligation of Political Subdivision to the County under this agreement. This deposit shall be paid to the County within ten (10) days of the Political Subdivision's receipt of this agreement, authorized by the governing bodies of both parties and fully executed by both parties. The exact amount of the Political Subdivision's obligation under the terms of this agreement shall be calculated after the November 3, 2020 election (or runoff election, if applicable), and if the amount of the Political Subdivision's obligation exceeds the amount deposited, the Political Subdivision shall pay to the County the balance due within thirty (30) days after receipt of the final invoice from the Elections Administrator. However, if the amount of the Political Subdivision's obligation is less than the amount deposited, the County shall refund to the Political Subdivision the excess amount paid within thirty (30) days after final costs are calculated.

Except as provided herein, all terms and conditions of the Contract shall remain unchanged.

ORDINANCE NO. 2020-10

AN ORDINANCE OF THE CITY OF RICHMOND, TEXAS, POSTPONING THE GENERAL ELECTION TO BE HELD ON MAY 2, 2020, FOR THE PURPOSE OF ELECTING A MAYOR FOR A TERM OF OFFICE FROM TO 2023 TO NOVEMBER 3, 2020 PURSUANT TO **PROCLAMATION FROM** GOVERNOR GREGORY PROVIDING FOR A JOINT ELECTION WITH OTHER ENTITIES CONTRACTING WITH FORT BEND COUNTY FOR THIS JOINT **ELECTION: PROVIDING FOR ELECTION PRECINCTS AND POLLING** PLACES: PROVIDING **FOR** REPEAL: **PROVIDING** FOR SEVERABILITY; AND CONTAINING OTHER PROVISIONS RELATING TO THE SUBJECT

WHEREAS, in December 2019 a novel coronavirus, now designated COVID-19, was detected in Wuhan City, Hubel Province, China. Symptoms of COVID-10 include fever, cough and shortness of breath. Outcomes have ranged from mild to severe illness; and

WHEREAS, on January 30, 2020, the World Health Organization Director General declared the outbreak of COVID-19 as a Public Health Emergency of International Concern ("PHEIC"), and advised countries to prepare for the containment, detection, isolation and case management, contact tracing and prevention of onward spread of the disease; and

WHEREAS, the identification of "community spread" cases of COVID-19 in the United States could potentially signal transmission of the virus may no longer be limited to travel to China, or contact with travelers who have visited China; and

WHEREAS, the Governor has issued a proclamation suspending certain provisions of the Texas Election Code and the Texas Water Code to allow all local political subdivisions that are utilizing the May 2, 2020 uniform election date to postpone their elections to the November 3, 2020 uniform election date; Now, Therefore,

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF RICHMOND, TEXAS:

<u>Section 1.</u> Pursuant to the proclamation from Governor Gregory Abbott, which authorizes the City Commission to make the determination to postpone the Uniform

Election Date of May 2, 2020 to the Uniform Election Date of November 3, 2020, the City Commission hereby approves and votes to exercise said authority and postponing the May 2, 2020 election to November 3, 2020.

<u>Section 2.</u> All applications for a ballot by mail ("ABBM") for voters that are voting by mail due to being over age sixty-five (65) or due to a disability will <u>STILL BE VALID</u> for the November 3, 2020 election, and the ABBMs for voters who submitted ABBMs based upon an expected absence from the county will <u>NOT BE VALID</u> for the November 3, 2020 election.

<u>Section 3.</u> The following dates will be followed for the November 3, 2020 Uniform Election Date:

- Voter registration deadline Monday, October 5, 2020
- Deadline to submit an application for ballot by mail October 23, 2020
- Early voting dates Monday, October 19, 2020 through Friday, October 30, 2020
- Last day of Early Voting by Personal Appearance Friday, October 30, 2020
- Last day to receive ballot by mail Tuesday, November 3, 2020 at 7:00 PM if carrier envelope is NOT postmarked, OR Wednesday, November 4, 2020 (next business day after Election Day) at 5:00 PM if carrier envelope is postmarked by 7:00 PM at the location of the election on Election Day (subject to overseas or military voter deadlines)
- Election Day-November 3, 2020.

<u>Section 4.</u> No later than August 17, 2020, the City Commission will make any necessary revisions of this order of election. Such revisions include, but are not limited to, change the date of the election; change the location of the main early voting location; changes to the early voting dates and hours; including weekend early voting; any changes to the identity of the early voting clerk and their contact information or any changes to branch early voting locations.

<u>Section 5.</u> The City Secretary shall cause the caption of this ordinance to be posted on the City's website and shall be published in the City's official newspaper.

<u>Section 6.</u> This Ordinance shall be and become effective immediately upon and after its passage and approval.

<u>Section 7.</u> Repeal. Any ordinance or other part of any other ordinance in conflict herewith shall be and is hereby repealed only to the extent of such conflict.

<u>Section 8.</u> Severability. In the event any section, paragraph, subdivision, clause, phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstance shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair, or invalidate this Ordinance as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Commission of the City of Richmond, Texas, declares that it would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, or whether there be one or more parts.

The proposed amendment aligns the section with the provisions of the state constitution and establishes the procedure for appointment to an unexpired term of 12 months or less.



Shall section 3.09 of the City Charter be amended to provide when two Commissioners are absent to count the presence of the Mayor toward the quorum of a Commission meeting and allow the Mayor to vote?

As currently written, section 3.09 contemplates a Mayor and two Commissioners.

The proposed amendment allows the Mayor to count toward the quorum when two Commissioners are absent. Three members of the governing body would be present, but no quorum would exist.

The proposed amendment also allows the Mayor to vote when two Commissioners are absent to help avoid a tie vote. The Mayor has authority to vote in case of a tie under section 3.04.

A recent decision of the 5th Court of Appeals (Dallas), Carruth v. Henderson, City Secretary 05-19-01195-CV, held that the city secretary must forward a referendum petition (to repeal the city's comprehensive plan) to the governing body for consideration, either repeal or call an election. The city's position was that the comprehensive plan was not subject to the referendum process. The proposed amendment is to expressly provide that the comprehensive plan and master plans will be excluded from the referendum process.



Shall section 11.01 of the City Charter be amended to authorize the City Commission to extend the boundaries of the city by annexation of property as provided by state law?

The annexation provisions of section 11.01 reflect the provisions of annexation law prior to the amendments made by the Legislature in 2017. Under current law, annexation generally requires consent of the property owner or approval by majority vote.

Texas Local Government Code, Section 43.0545, requires that the area being annexed be contiguous to the municipal boundaries. Other sections provide limited exceptions, as municipal-owned property and land within a utility district with a strategic partnership agreement allowing non-contiguous annexation.

The proposed amendment would allow the City to negotiate strategic partnership agreements to include non-contiguous annexation.

ORDINANCE NO. 2020-21

AN ORDINANCE CALLING A SPECIAL ELECTION TO BE HELD ON NOVEMBER 3, 2020 IN THE CITY OF RICHMOND, TEXAS TO SUBMIT PROPOSITIONS ON AMENDMENTS TO THE CITY OF RICHMOND HOME RULE CHARTER, RELATING TO ELECTION OF MAYOR AND COMMISSIONERS BY MAJORITY VOTE; FILLING A VACANCY IN THE OFFICE OF MAYOR OR COMMISSIONER; IN THE EVENT OF THE ABSENCE OF TWO COMMISSIONERS, COUNTING THE MAYOR'S PRESENCE TOWARD THE QUORUM AND ALLOWING THE MAYOR TO VOTE; ALLOWING THE CANCELLATION OF A GENERAL ELECTION AS PROVIDED BY STATE LAW; PRECLUDING THE REFERENDUM PROCESS FROM APPLYING TO COMPREHENSIVE PLANS AND PLANS: ALLOWING THE ANNEXATION OF ADDITIONAL TERRITORY AS PROVIDED BY STATE LAW; MAKING PROVISION FOR THE CONDUCT OF THE ELECTION; RESOLVING OTHER MATTERS INCIDENT AND RELATED TO SUCH ELECTION; PROVIDING FOR SEVERABILITY; AND CONTAINING OTHER PROVISIONS RELATING TO THE SUBJECT.

WHEREAS, the City Charter of the City of Richmond ("City") was adopted in May 2013, and has served the City well; and

WHEREAS, in accordance with Section 10.04 of the Richmond City Charter, in 2015, the City Commission appointed a fifteen (15) member Charter Review Commission to determine whether any Charter provisions require revision; and

WHEREAS, based on the report of the Charter Review Commission and a petition proposing an amendment to require single member districts, and a recommendation from staff, the City Commission called a Charter amendment election held on May 7, 2016; and

WHEREAS, as a result of the election, the proposed amendments, except the single member district election, were approved; and

WHEREAS, staff review of the Charter, as amended, has technical inconsistencies and does not provide for authority consistent with state laws; and

WHEREAS, pursuant to the authority granted in Secs. 10.03 and 10.05 of the Charter and Sec. 9.004, Texas Local Government Code, the City Commission proposes to present to the qualified voters of the city propositions to amend the Charter to provide for election of the Mayor and each Commissioner by majority vote; the procedure for filling a vacancy in the office of Mayor or the office of City

Commissioner; in the event of the absence of two Commissioners, counting the Mayor's presence toward the quorum and allowing the Mayor to vote; allowing the cancellation of a general election pursuant to state law; precluding the referendum process from applying to the repeal of comprehensive plans and master plans; and providing for the annexation of additional territory as provided by state law; and

WHEREAS, pursuant to Texas Local Government Code Section 9.004(e), the ballot shall be prepared so that a voter may approve or disapprove any one or more amendments without having to approve or disapprove all of the amendments; and

WHEREAS, the City Commission hereby finds and determines that propositions to be submitted are in compliance with the Texas Local Government Code and that the holding of this election on the uniform election date set forth below is in conformance with all applicable election laws, **NOW**, **THEREFORE**,

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF RICHMOND, TEXAS THAT:

<u>SECTION 1.</u> A Special Election shall be held on the 3RD day of November, 2020, a uniform election date, in the CITY OF RICHMOND, TEXAS, ("City") which date is not less than thirty (30) days from the date of the adoption of this ordinance (the "Ordinance"), for the purpose of submitting the following propositions to the qualified voters of the City to amend the Charter of the City. Said election shall be held in accordance with the Texas Election Code.

<u>SECTION 2.</u> Ballot Propositions. The official ballots shall be prepared in accordance with the Texas Election Code, as amended, so as to permit electors to vote "FOR" or "AGAINST" the aforesaid proposition. Voters should place an "X" in the square beside the statement indicating the way they wish to vote.

<u>SECTION 3.</u> The following measures will be submitted to the qualified voters of the City at the election to be held on the date specified in the previous section in the form of propositions in accordance with Section 9.004 of the Texas Local Government Code and the City Charter.

I. <u>AMENDMENTS</u>

PROPOSITION ONE

Shall Sections 5.02 and 5.11 of the City Charter be amended to provide for the Mayor and each Commissioner be elected by majority vote?

If Article V, Sections 5.02 and 5.11 of the City Charter is amended to provide for the election of the Mayor and each Commissioner by majority vote, the section shall read as follows:

Sec. 5.02. - General Elections.

The general City election shall be held annually on the first Saturday in May, or if such not be authorized, the date nearest thereto as may be established by law. The Mayoral or Commission candidate for elective office receiving a <u>majority of the votes cast at the election</u>, meaning <u>more than fifty percent (50%) of number of the votes cast for the office</u> shall be declared the winner.

Sec. 5.11. - Term of Office.

The Mayor and each Commission Member shall serve until his or her successor is elected or appointed and qualified to serve. The regular term of office of the Mayor and the Commission Members shall commence at the first Commission meeting following the canvass of the election at which they receive a majority vote. A Member of the Commission elected in a run-off election shall take office at the first Commission meeting following the day on which the votes for the run-off election are canvassed. The remaining term of a Member of Commission elected at a special election shall commence at the first Commission meeting after the canvass of votes for the election at which they receive the majority of votes cast for the office.

PROPOSITION TWO

Shall Section 3.05 of the City Charter be amended to provide a procedure for appointment to fill a vacancy in the office of Mayor or Commissioner when the remaining term is twelve months or less and require an election when the remaining term is greater than twelve months?

If Article III, Section 3.05 of the City Charter is amended to define the procedure for appointment to fill a vacancy in the office of Mayor or Commissioner when the term is twelve months or less and to require an election when the remaining term is more than twelve months, the section shall read as follows:

Sec. 3.05. - Vacancies, Forfeiture and Filling of Vacancies.

- (1) The office of a Commission Member or the Mayor shall become vacant upon his/her death, resignation, forfeiture of, or removal from office by any manner authorized by law or this Charter.
- (2) If the Mayor or any member of the City Commission is absent from three (3) consecutive regular meetings without explanation acceptable to a majority of the remaining Commission Members, his/her office shall be declared vacant at the next regular meeting of the City Commission by resolution. Mayor may vote on this Resolution only to obtain the required two (2) vote minimum per Section 3.09.
- (3) Any person on the City Commission who ceases to possess the required qualifications for office or who is convicted of a felony or of a misdemeanor involving moral turpitude or is convicted of violating any state laws or City ordinance regulating conflicts of interest of municipal officers shall forfeit his/her office. Every forfeiture shall be declared by Resolution and enforced by the City Commission.
- (4) If there is a vacancy in the office of Mayor when the unexpired term of office is 12 months or less, the Mayor Pro Tem may serve as Mayor until the next municipal election at which time a new Mayor shall be elected in accordance with the Texas Election Code. If the Mayor Pro Tem should refuse to serve as Mayor, one of the remaining City Commission members, may be selected by majority vote of the remaining City Commissioners, to serve as Mayor until the next municipal election at which time a new Mayor shall be elected in accordance with the Texas Election Code. If the remaining Commission Members refuse to serve as Mayor, the Commission may appoint a qualified resident to serve as Mayor for the remainder of the unexpired term. The vacancy created by the Mayor Pro Tem or a Commission Member being appointed to Mayor may be filled as set forth in subsection (6) or (7) below.

(5) If there is a vacancy in the office of Mayor when the unexpired term of office is greater than 12 months, an election shall be called in accordance with the Texas Election Code for the election of a new Mayor. The Mayor Pro Tem shall serve as the presiding officer until the election and qualification of a new Mayor. Should the Mayor Pro Tem decline to serve as the presiding officer, the remaining Commissioner Members, by majority vote, may select one of the remaining City Commissioners to serve as presiding officer until the election and qualification of a new Mayor. The Mayor shall appoint a new Mayor Pro Tem at the next regular meeting after the vacancy is filled.

(6) If a vacancy in the City Commission were to occur and the unexpired term is 12 months or less, other than that of the Mayor, that position may be filled by selection of a person qualified for the position, as described in this Charter, within thirty (30) days of the occurrence of the vacancy by nomination by the Mayor or any Commissioner and a vote of the remaining Commission Members and the Mayor.

(7) If the vacancy in the City Commission were to occur and the unexpired term of the vacated place on the Commission is greater than 12 months, that position must be filled by election in accordance with state law.

(8) All vacancies filled by appointment or election shall be for the remainder of the unexpired term of the office so filled. Specifically, any person elected to a vacancy that occurs in the first or second year of a three-year term shall serve out the remainder of that term.

PROPOSITION THREE
