# **ORDINANCE 2020-27**

AN ORDINANCE BY THE CITY OF RICHMOND CERTIFYING THE ELECTION RESULTS OF THE GENERAL ELECTION HELD IN THE CITY OF RICHMOND, FORT BEND COUNTY, TEXAS, ON NOVEMBER 3, 2020.

WHEREAS, on November 3, 2020 a general election was held in the City of Richmond, Fort Bend County, Texas to vote on the election of the Mayor; and

WHEREAS, notice of said election has been given to the qualified voters of the City and all other interested persons as required by law; and

WHEREAS, section 67.003 of the Texas Election Code, as amended, generally provides that each local canvassing authority shall convene no earlier than the third day or no later than the eleventh (11th) day after the election date for the purpose of canvassing the election results; and

WHEREAS, all mail in ballots and provisional ballots have been counted; and

WHEREAS, the returns of said election were regularly made to the City Commission by the officers of said election as provided by the Texas Election Code, as amended, and after canvassing the returns of said election, does hereby find and declare the results as follows:

For the position of Mayor, the following votes were cast:	<u>FINAL</u>

TOTAL VOTES	2,754

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF RICHMOND, TEXAS, THAT:

**Section 1**. Said election was duly called, notice thereof given in accordance with law, and conducted in the manner required by law and as provided in the Order Calling the Election.

**Section 2.** A tabulation of votes cast in the General Election held on November 3, 2020, for the purposes of electing the Mayor is adopted as the official tabulation of the votes cast at the election, and the tabulation will be filed and recorded in the official records of the City of Richmond as the official canvass of the election.

**Section 3**. That Rebecca Kennelly Haas received a majority of the votes and is elected to serve as Mayor.

Section 4. Commencing on the first City Commission meeting following this Canvass and upon qualification for office, Rebecca Kennelly Haas shall have a term as Mayor that continues until the General Election to be held in May 2023.

Section 5. If any part or parts of this Ordinance are found to be invalid or unconstitutional by a court having competent jurisdiction, then such invalidity or unconstitutionality shall not affect the remaining parts hereof and such remaining parts shall remain in full force and effect, and to that extent this Ordinance is considered severable.

This Ordinance will become effective immediately upon its passage by the Richmond City Section 6. Commission.

**CONSIDERED PASSED and APPROVED**, this 16<sup>th</sup> day of November, 2020, at a meeting of the City Commission of the City of Richmond, Texas, at which a quorum was present and which was held in accordance with Chapter 551, Texas Government Code.

# **ORDINANCE 2020-28**

AN ORDINANCE BY THE CITY OF RICHMOND CERTIFYING THE ELECTION RESULTS OF THE SPECIAL ELECTION HELD IN THE CITY OF RICHMOND, FORT BEND COUNTY, TEXAS, ON NOVEMBER 3, 2020.

WHEREAS, on November 3, 2020 a special election was held to vote on proposed Charter amendments; and

WHEREAS, notice of said election has been given to the qualified voters of the City and all other interested persons as required by law; and

WHEREAS, section 67.003 of the Texas Election Code, as amended, generally provides that each local canvassing authority shall convene no earlier than the third day or no later than the eleventh (11th) day after the election date for the purpose of canvassing the election results; and

WHEREAS, all mail in ballots and provisional ballots have been counted; and

WHEREAS, the returns of said election were regularly made to the City Commission by the officers of said election as provided by the Texas Election Code, as amended, and after canvassing the returns of said election, does hereby find and declare the results as follows:

# PROPOSITION ONE

If Article V, Sections 5.02 and 5.11 of the City Charter is amended to provide for the election of the Mayor and each Commissioner by majority vote, the section shall read as follows:

### Sec. 5.02. - General Elections.

The general City election shall be held annually on the first Saturday in May, or if such not be authorized, the date nearest thereto as may be established by law. The Mayoral or Commission candidate for elective office receiving a pluralitymajority of the votes cast at the election, meaning the greatest more than fifty percent (50%) of number of the votes cast for the office shall be declared the winner.

### Sec. 5.11. - Term of Office.

The Mayor and each Commission Member shall serve until his or her successor is elected or appointed and qualified to serve. The regular term of office of the Mayor and the Commission Members shall commence at the first Commission meeting following the canvass of the election at which they receive a majority vote. A Member of the Commission elected in a run-off election shall take office at the first Commission meeting following the day on which the votes for the run-off election are canvassed. The remaining term of a Member of Commission elected at a special election shall commence at the first Commission meeting after the canvass of votes for the election at which they receive the mest-majority of votes cast for the office.

# **PROPOSITION TWO**

If Article III, Section 3.05 of the City Charter is amended to define the procedure for appointment to fill a vacancy in the office of Mayor or Commissioner when the term is twelve months or less and to require an election when the remaining term is more than twelve months, the section shall read as follows:

# Sec. 3.05. - Vacancies, Forfeiture and Filling of Vacancies.

- (1) The office of a Commission Member or the Mayor shall become vacant upon his/her death, resignation, forfeiture of, or removal from office by any manner authorized by law or this Charter.
- (2) If the Mayor or any member of the City Commission is absent from three (3) consecutive regular meetings without explanation acceptable to a majority of the remaining Commission Members, his/her office shall be declared vacant at the next regular meeting of the City Commission by resolution. Mayor may vote on this Resolution only to obtain the required two (2) vote minimum per Section 3.09.
- (3) Any person on the City Commission who ceases to possess the required qualifications for office or who is convicted of a felony or of a misdemeanor involving moral turpitude or is convicted of violating any state laws or City ordinance regulating conflicts of interest of municipal officers shall forfeit his/her office. Every forfeiture shall be declared by Resolution and enforced by the City Commission.
- (4) If there is a vacancy in the office of Mayor when the unexpired term of office is 12 months or less, the Mayor Pro Tem will-may serve as Mayor until the next municipal election at which time a new Mayor shall be elected in accordance with the Texas Election Code. If the Mayor Pro Tem should refuse to serve as Mayor, one of the remaining City Commission members, shall—may be selected by majority vote of the remaining City Commissioners, to serve as Mayor until the next municipal election at which time a new Mayor shall be elected in accordance with the Texas Election Code. If the remaining Commission Members refuses to serve as Mayor, the Commission may appoint a qualified resident to serve as Mayor for the remainder of the unexpired term. The vacancy created by the Mayor Pro Tem or a Commission Member being appointed to Mayor may be filled by selection of a person qualified for the position, as described in this Charter, within thirty (30) days of the occurrence of the vacancy by a majority vote of the remaining Commission Members as set forth in subsection (6) or (7) below. This appointee shall serve until the next municipal election at which time a new Commission Member shall be elected in accordance with the Texas Constitution and the Texas Election Code.
- (5) If there is a vacancy in the office of Mayor when the unexpired term of office is greater than 12 months, an election shall be called in accordance with the Texas Election Code for the election of a new Mayor. The Mayor Pro Tem shall serve as the presiding officer until the election and qualification of a new Mayor. Should the Mayor Pro Tem decline to serve as the presiding officer, the remaining Commissioner Members, by majority vote, may select one of the remaining City Commissioners to serve as presiding officer until the election and qualification of a new Mayor. The Mayor shall appoint a new Mayor Pro Tem at the next regular meeting after the vacancy is filled.
- (56) A-If a vacancy in the City Commission where were to occur and the unexpired term is less than one year 12 months or less, other than that of the Mayor, that position shall may be filled by selection of a person qualified for the position, as described in this Charter, within thirty (30) days of the occurrence of the vacancy by nomination by the Mayor or any Commissioner and a vote of the remaining Commission Members and the Mayor.
- (7) This appointee shall serve until the next municipal election at which time a new Commission Member shall be elected in accordance with the Texas Constitution and the Texas Election Code. If the vacancy in the City Commission were to occur and a year or more is left on the unexpired term of the vacated place on the Commission is greater than 12 months, that position must be filled by election in accordance with state law.
- (68) All vacancies filled by appointment or election shall be for the remainder of the unexpired term of the office so filled. Specifically, any person elected to a vacancy that occurs in the first or second year of a three-year term shall serve out the remainder of that term.

# PROPOSITION THREE

If Article III. Section 3.09 of the City Charter is amended to provide when two Commissioners are absent to count the presence of the Mayor toward the quorum of a Commission meeting and allow the Mayor to vote, the section shall read as follows:

# Sec. 3.09. - Quorum.

A majority of Commission Members shall constitute a quorum for the purpose of transacting business. No action of the City Commission, except as specifically provided in this Charter, shall be valid or binding unless adopted by the affirmative vote of a majority of the City Commission places occupied at the time of the vote. The presence of the Mayor at any Commission meeting shall not count toward a quorum unless atwo Commissioners is are absent, then the Mayor does count toward a guorum and is allowed to vote on all matters during the absence of the Commissioners. No Ordinance, Resolution or action by the City Commission shall be binding unless the matter receives two (2) affirmative votes.

# PROPOSITION FOUR

If Article V. Section 5.02 of the City Charter is amended to authorize the City Commission to cancel a general election as provided by state law, the section shall read as follows:

# Sec. 5.02. - General Elections.

The general City election shall be held annually on the first Saturday in May, or if such not be authorized, the date nearest thereto as may be established by law. The general election may be cancelled as provided by state law. The Mayoral or Commission candidate for elective office receiving a plurality, meaning the greatest number of the votes cast shall be declared the winner.

# PROPOSITION FIVE

If Article VI. Section 6.03 of the City Charter is amended to remove comprehensive plans and master plans from the referendum process, the section shall read as follows:

## Sec. 6.03. - Referendum.

The people of the City shall have the power to require reconsideration by the Commission of any adopted ordinance regarding any issue that would be a proper subject for an initiative, and if the Commission fails to repeal an ordinance so reconsidered, to approve or reject the ordinance at an election. Such power shall not extend to the budget; capital expenditures; levy of taxes; any bonds, certificates of obligation or any similar obligations; zoning; comprehensive or master plans; annexation; or any rates, fees and charges; provided that tax increases shall be subject to petition as provided by state law.

# PROPOSITION SIX

If Article XI. Section 11.01 of the City Charter is amended to authorize the City Commission to extend the boundaries of the city by annexation of property as provided by state law, the section shall read as follows:

# Sec. 11.01. - Annexation; Extensions of Boundaries.

The boundaries of the City may be enlarged and extended by the annexation of additional territory, irrespective of size and configuration, by the methods hereinafter set forthas may be prescribed by state law.

- (1) (A) City Initiated Annexation. The City Commission shall have the power by ordinance to fix the boundary limits of the City and to provide for the alteration and extension of said boundary limits and the annexation of additional territory, lying adjacent to the City, in the manner provided by state law.
- (B) The City Commission may also initiate the process of annexation of contiguous and adjacent land within the existing extraterritorial jurisdiction boundaries and under such procedural rules as may be prescribed by state law. (C) The City Commission may also initiate the process of annexation of annex city-owned property as may be prescribed by state law.
- (2) Voluntary Annexation. The owner or owners of any land contiguous and adjacent to the City may, by petition in writing to the City Commission, request the annexation of such contiguous and adjacent land. The City Commission shall hold a public hearing with the arguments for and against the proposed annexation. If the City Commission chooses to grant such petition, it may, by proper ordinance, under such procedural rules as may be prescribed by state law, receive and annex such territory as a part of the City.
- (3) When any additional territory has been so annexed, the same shall be a part of the City and the property situated therein shall bear its pro rata part of the taxes levied by the City. The inhabitants thereof shall be entitled to all the rights and privileges of the other citizens of the City and shall be bound by the acts, ordinances, resolutions and regulations of the City.
- (43) The extraterritorial jurisdiction boundaries may be extended by the Commission as provided by state law.

WHEREAS, the returns of said election were regularly made to the City Commission by the officers of said election as provided by the Texas Election Code, as amended, and after canvassing the returns of said election, does hereby find and declare the results as follows:

# PROPOSITION ONE

Shall Sections 5.02 and 5.11 of the City Charter be amended to provide for the Mayor and each Commissioner be elected by majority vote?

## PROPOSITION TWO

Shall Section 3.05 of the City Charter be amended to provide a procedure for appointment to fill a vacancy in the office of Mayor or Commissioner when the remaining term is twelve months or less and require an election when the remaining term is greater than twelve months?

Votes cast for 2,260 Votes cast against 548 Total Votes Cast 2,808

# PROPOSITION THREE

Shall section 3.09 of the City Charter be amended to provide when two Commissioners are absent to count the presence of the Mayor toward the quorum of a Commission meeting and allow the Mayor to vote?

Votes cast for 1,815 Votes cast against 976 Total Votes Cast 2,791

# PROPOSITION FOUR

Shall section 5.02 of the City Charter be amended to authorize the City Commission to cancel a general election as provided by state law?

Votes cast for 1,423 Votes cast against 1,328 Total Votes Cast 2,751

### PROPOSITION FIVE

Shall section 6.03 of the City Charter be amended to preclude the referendum process from applying to comprehensive and master plans?

Votes cast for 1,618 Votes cast against 1,054 Total Votes Cast 2,672

### PROPOSITION SIX

Shall section 11.01 of the City Charter be amended to authorize the City Commission to extend the boundaries of the city by annexation of property as provided by state law?

Votes cast for 1,934 Votes cast against 905 Total Votes Cast 2,839

# NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF RICHMOND, TEXAS, THAT:

**Section 1**. Said election was duly called, notice thereof given in accordance with law, and conducted in the manner required by law and as provided in the Order Calling the Election.

**Section 2**. A tabulation of votes cast in the Special Election held on November 3, 2020, for the purposes deciding whether to amend the City Charter is adopted as the official tabulation of the votes cast at the election, and the tabulation will be filed and recorded in the official records of the City of Richmond as the official canvass of the election.

**Section 3.** That a majority of the resident, qualified electors of the City voting in the special election:

- voted "FOR" Proposition 1;
- voted "FOR" Proposition 2;
- voted "FOR" Proposition 3;
- voted "FOR" Proposition 4;
- voted "FOR" Proposition 5; and
- voted "FOR" Proposition 6.

**Section 4**. If any part or parts of this Ordinance are found to be invalid or unconstitutional by a court having competent jurisdiction, then such invalidity or unconstitutionality shall not affect the remaining parts hereof and such remaining parts shall remain in full force and effect, and to that extent this Ordinance is considered severable.

**Section 5.** The Mayor or City Manager shall certify to the secretary of state an authenticated copy of the charter amendment under the municipality's seal showing the approval by the voters of the City of Richmond.
