PURPOSE: To receive comments for or against a request by Randy McClendon on behalf of Shakil Lakhani and Anita Kermally, to replat approximately 1.016 acre tract of land in the Joseph Kuykendahl League Survey, Abstract No. 49; also being a replat of Lots 19 & 20 of Block 2, Estates at Lakes of Williams Ranch Sec. 1 as recorded in Plat No. 20180168 of the Fort Bend County Plat Records to create one lot. The proposed replat is called Estates at Lakes of Williams Ranch Sec. 1, Partial Replat No. 4.

SITE LOCATION: The subject site is part of Lakes of Williams Ranch Residential subdivision and is located at the northwestern corner of the Alexandra Way Circle cul-de-sac.

SITE LEGAL DESCRIPTION: The subject site can be described as approximately 1.016 acres of land being all of lots 19 & 20 of Block 2, Estates at Lakes of Williams Ranch Sec. 1, as recorded in Plat No. 20180168 of the Fort Bend County Plat Records.
