The City Commission for the City of Richmond, Texas met in Workshop Session on April 8, 2021 at 9:00 a.m.

Mayor Becky Haas proceeded to call the meeting to order at 9:16 a.m. The meeting was broadcast via video conference call. All members of the public may participate in the meeting and via video conference call.

Mayor Haas introduced agenda item A2, Discuss FY 2021-2022 Budget, Financial Objectives and Priorities of the Commission. Finance Director Justin Alderete led the discussion with interjections from Terri Vela, City Manager. The Assistant Finance Director Isaias Preza provided a portion of the presentation. The goal of the Workshop was to receive guidance from the Commission regarding the Budget, the priorities and opinions. Projections for the future growth of the City were provided for the Commission to get an overview of where the City possibly will be with the Veranda and Mandola Farms based on the information staff knows today. The following topics were covered and there was a lengthy discussion of each one with questions being posed.

Finance Director Alderete reviewed each topic in detail providing economic projections and requesting guidance. The Commission expressed the need to plan, have policies and be proactive not reactive. The future growth of the City is exciting, but the infrastructure will need to be developed to prepare for the growth.

The meeting reconvened at 12.41 p.m.

The City Limits have 34.09% tax exempt property therefore when comparisons are made with other cities regarding tax rates, it is not an equal comparison. The City of Richmond's commercial base is lower as well. There was discussion on the upcoming garbage contract. The economic effect of allowing over 65 exemptions on the properties was reviewed. There were question and answer periods throughout the workshop.
