- Finance Director Preza provided a presentation that was based on feedback from the City Commission members during the August 22nd meeting. He elaborated on the budget adoption process. CM Vela mentioned that having the option of an FTE provides flexibility. Commissioner Gaul inquired about the City Commission's role in filling the DCR position, to which CM Vela replied that they wouldn't be involved. Commissioner Gaul expressed the need to understand the DCR position's scope compared to the Economic Director position before supporting it. Some City Commission members suggested that budget approval could be contingent on the DCR position. Commissioner Beard voiced concerns about the City Commission voting on a DCR position.
- Commissioner BeMent made a motion to set a date for the adoption of Proposed FY 2023-24
   Budget as September 18, 2023 in accordance with section 102.007 of the Local Government
   Code. Commissioner Drozd seconded. Motion passes unanimously.
