Agenda Item A4. Review and consider taking action on Ordinance No. 2023-28, authorizing the issuance of City of Richmond, Texas Combination Tax and Revenue Certificates of Obligation, Series 2023A.

- FD Isaias Preza stated the bond revenue will fund Mandola and Veranda In-City development reimbursements, PD renovations including administration roof replacement, and funding for phase II of Morton Street parking. Joe Morrow with Hilltop Securities addressed the City Commission stating they sold the city's Certificate of Obligations this morning in a competitive sale. He went on to cover details of the pricing book and stated S&P confirmed the city's outstanding rating of AA-. He then received questions for clarification from members of the City Commission.
- Commissioner BeMent moved to approve Ordinance No. 2023-28 an Ordinance of The City of Richmond, Texas, Authorizing the Issuance of City Of Richmond, Texas Combination Tax And Revenue Certificates Of Obligation, Series 2023A. Commissioner Beard seconded. Motion passes unanimously by the following vote:

• City Attorney Smith provided information on suggested revisions to the Rules of received during a training session with chairs and vice-chairs of boards and commissions, specifically Sec. C.4, D.3., D.6, and F.2. There was discussion with the City Commission that covered recommended revisions to the Rules of Commission. Members of the City Commission asked questions and provided feedback such as simplifying language, so rules are not repeated, amendment of motions and adding language as it relates to the amendment of motions to cover the second, including language regarding adjournment relating to processes, and including staff in the protection of decorum. Further discussion covered Sec. I.1, Citizen Participation at Meetings and reading or not reading written submittals during the Public Comments section, however including a summary such as for/against is favorable.
