Parks and Recreation Board Meeting Minutes

Wednesday, March 13, 2024, at 4:00 p.m.

The Parks and Recreation Board for the City of Richmond, Texas met in a regular meeting on Wednesday, March 13, 2024, at 4:00 p.m. Chairman Haas, called the meeting to order at 4:00 p.m. A quorum was present, with the following members in attendance:

Staff in attendance: Howard Christian, Assistant City Manager; Jim Whitehead, Assistant Public Works Director; Gary Smith, City Attorney; and Brittany Mullings, Executive Secretary.

Chairman Haas introduced agenda item A2., Recite the Pledge of Allegiance to the U.S. Flag and Texas Flag. The Pledge of Allegiance to the U.S. Flag and Texas Flag was recited by the Board.

Chairman Haas introduced agenda item A3., Public Comments. He asked if there were any public comments. Hearing no public comments, the agenda item was closed.

Chairman Haas introduced consent agenda item B1., Review and approve minutes of the Regular Meeting held on Wednesday, February 14, 2024. Board Member Farris moved to approve the meeting minutes. Board Member Hodge seconded the motion. The vote for approval was unanimous.

Chairman Haas introduced consent agenda item B2., Date and time of next meeting: The next meeting will be held on Wednesday, April 10, 2024, at 4:00 p.m. All Board Members were in favor of the date of the next meeting and there was no objection to the new proposed time.

Chairman Haas introduced regular agenda item C1., Monthly Park Board Report to City Commission. None to discuss.

Chairman Haas introduced regular agenda item C2., Keep Richmond Beautiful (KRB) Committee.

- a) KRB Monthly Report. Ms. Pittman stated that the spring clean-up at City Hall Park was completed by KRB. As far as the Morton Street Planters are concerned, they have removed most of the dead plants, so that they may be refreshed on a later date. The Master Gardners invited Ms. Pittman to a tour of their garden and to learn more about the plants and maintenance of their Butterfly Garden.
- b) KRB Notifications, Requests, Projects, Plans, and Others. Ms. Pittman distributed copies of the buck slips that were included with utility bills, as well as flyers for the Shred/Electronic Event and Tire Round-Up. On April 13, 2024, the Shred & Electronic Event at City Hall Park and the Tire Round-Up at the City Maintenance Facility at 106 N Second Street will both take place from 9:00 a.m. to noon.
- c) Membership for KRB. No discussion.

Chairman Haas introduced regular agenda item C3., Decker Park update. Executive Director, Madeleine Calcote-Garcia of the Fort Bend History Association presented the Board with a report regarding Decker Park. Chairman Haas read the report to the Board. Report attached.

Chairman Haas introduced regular agenda item C4., An update on the Traffic Signal Wraps. Mr. Christian stated the information has been provided to Carmen Flores, Catapult Art Studio Owner. Chairman Haas asked if funds should be allocated to the traffic signal wrap at South 11th and Jackson Street, since this intersection will become obsolete as a result of the Clay and Second Street Project. Mr. Christian stated that we would reevaluate the matter once it becomes closer to submitting the final approved product to the vendor.

Chairman Haas introduced regular agenda item C5., General discussion on the proposed neighborhood park near Juan Seguin Early Childhood Center. Mr. Christian did not have an update at this time.

Chairman Haas introduced regular agenda item C6., Staff Information Reports. Mr. Whitehead stated all picnic tables at George Park have been repaired or replaced, and the playground equipment has been power washed. The pavilion at Clay Park was power washed and the playgrounds have all been mulched. In preparation for the upcoming planting season, we are mowing the sports fields twice a week and checking the sprinkler systems.

Chairman Haas introduced regular agenda item C7., Park visits by Park Board Members. Board Member Farris visited all the parks, except for Geroge Park. She stated they all looked nice. Vice-Chair Torres mentioned the trail at George Park looked great. Board Member Pittman visited all the parks, all looked good. Board Member Cortinas mentioned the hand dryer in the men's restroom at George Park does not work, also there was a dumped mattress by the pavilion. Chairman Haas was at George Park on the softball season opening day. He mentioned everyone was having a great time and the park looked good.

Chairman Haas introduced regular agenda item C8., Future agenda items. Chairman Haas would like to leave the updates for the Traffic Wraps and Decker Park on the agenda.

Chairman Haas introduced regular agenda item C9., Excuse from attendance at regular Park and Recreation Board Meeting. Board Member Pittman moved to approve the absence of Board Member Pella. The motion was seconded by Board Member Hodge. The vote for approval was unanimous.

There being no further business to be brought before the Parks and Recreation Board, Chairman Haas adjourned the meeting at 4:27 p.m.



Decker Park Report - March 13, 2024

- The Fort Bend History Association Board of Trustees and Staff have set strategic priorities for the organization, one of which is reviewing our resources and assets, including Decker Park.
- Leadership is completing a resource review process, in which we critically analyze each of our assets, specifically in regard to buildings and property.
- Decker Park, the Train Depot and the McNabb House are all included in that process.
- We hope to complete this process in late spring.
- When we've completed the process, we would like to host a roundtable with community
 members and stakeholders, including the City of Richmond, to discuss the possibilities
 with Decker Park.
