Charles Louis Curtis was born in Madisonville, Kentucky, in 1944, to Frank and Lucy Ellen Curtis. Frank was from Madisonville. Kentucky, and Lucy Ellen was from Sturgis, Kentucky. The three moved to Bloomfield Hills, Michigan. Charles' brother Ed Curtis was born. Sadly, Lucy Ellen passed away not long after. Ed was very young and Charles was a teenager. Ed would often speak of how Charles helped to raise him. Frank would go on to remarry a lifelong friend from Madisonville, Mildred Brewer, also a widow, and mother of two sons, Allen and Tim. All would live in Detroit, Michigan, where Charles' father Frank was respected and employed in the automotive industry.

#### NOTICE OF TAXPAYERS' RIGHT TO ELECTION TO REDUCE TAX RATE

If the district adopts a combined debt service, operation and maintenance, and contract tax rate that would result in the taxes on the average residence homestead increasing by more than eight percent, the qualified voters of the district by petition may require that an election be held to determine whether to reduce the operation and maintenance tax rate to the voter-approval tax rate under Section 49.23603, Water Code.

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

## NOTICE OF PUBLIC **HEARING FISCAL YEAR** 2025 PROPOSED BUDGET

The City of Richmond will hold a public hearing at 4:30 p.m. on Tuesday, September 10, 2024, for the Proposed Fiscal Year 2025 Budget at 600 Morton Street, Richmond, Texas 77469, in the City Commission Chambers.

In accordance with Texas Local Government Code Section 102.005(b): This budget will raise more total property taxes than last year's budget by \$112,477 or 1.62%, and of that amount, \$257,527 is tax revenue to be raised from new property added to the tax roll this year.

At said time and place, all such persons shall have the right to appear and be heard. The proposed budget is available on the website at www.richmondtx.gov and also is available for review in the City Secretary's office at City Hall, 402 Morton Street, Richmond, Texas 77469.

#### NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.400000 per \$100 valuation has been proposed by the governing body of City of Needville.

\$0.400000 per \$100 PROPOSED TAX RATE \$0.330192 per \$100 NO-NEW-REVENUE TAX RATE VOTER-APPROVAL TAX RATE \$0.420842 per \$100

The no-new-revenue tax rate is the tax rate for the 2024 tax year that will raise the same amount of property tax revenue for City of Needville from the same properties in both the 2023 tax year and the 2024 tax year.

The voter-approval rate is the highest tax rate that City of Needville may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that City of Needville is proposing to increase property taxes for the 2024 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 5, 2024 AT 6:00pm AT Needville City Hall, 9022 Main Street Needville TX 77461.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, City of Needville is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the City Council of City of Needville at their offices or by attending the public hearing mentioned above. YOUR TAXES OWED UNDER ANY OF THE RATES MENTIONED ABOVE CAN BE CALCULATED AS FOLLOWS:

- **Budget Adoption** 
  - Budget must be approved before the Tax Rate
  - Simple majority
- **III.** Public Hearing on the Tax Rate
- IV. Approval of the Tax Rate
  - Super majority
  - > Adopted in two parts
    - Maintenance & Operations
    - Debt Service
- Record vote to ratify the tax rate increase in the budget
  - I. Separate Item on the agenda




## Staff's Recommendation
